1 TO THE CLERK OF THE COURT, ALL PARTIES, AND THEIR RESPECTIVE
2 ATTORNEYS OF RECORD, PLEASE TAKE NOTICE:

3 Google and its counsel provided disclosures regarding the Proposed Cy Pres Recipients at
4 ECF No. 332, while Lead Class Counsel provided disclosures at ECF No. 338. Based on the
5 Court's comments at the October 26, 2023 preliminary approval hearing, developments after the
6 hearing, and in an abundance of caution, the parties hereby supplement those disclosures as
7 follows:

8 1. Attorneys at Kecker, Van Nest & Peters, Ahdoot & Wolfson, Lief Cabraser
9 Heimann & Bernstein, and employees at Google LLC have attended (among others) the following
10 undergraduate and graduate schools affiliated with Proposed Cy Pres Recipients: Harvard
11 University, Yale University, New York University, Fordham University, and the Massachusetts
12 Institute of Technology. One of the attorneys who has entered an appearance for Plaintiffs in this
13 action graduated from Harvard University. Two additional attorneys representing Plaintiffs
14 graduated from Harvard Law School. One of the attorneys representing Plaintiffs graduated from
15 New York University School of Law. The attorneys currently representing Google in this action
16 include two graduates of Harvard Law School (one of whom also serves as a board member of the
17 Harvard Law School Association of Northern California) and two graduates of Yale Law School
18 (one of whom also received an undergraduate degree from Harvard University).

19 2. The parties have received notice that the Georgetown Law Center for Privacy &
20 Technology intends to submit a proposal for a Cy Pres award from the Settlement. Attorneys at
21 Kecker, Van Nest & Peters, Ahdoot & Wolfson, and Lief Cabraser Heimann & Bernstein, and
22 employees at Google LLC have graduated from Georgetown University and/or Georgetown
23 University Law Center.

24 3. An associate at Lief Cabraser Heimann & Bernstein who has entered an
25 appearance for Plaintiffs in this action is expected to join the Board of Directors of the ACLU
26 Foundation of Northern California in 2024.

1 4. Loeff Cabraser Heimann & Bernstein is currently exploring a potential
2 collaboration with the ACLU of Northern California to jointly pursue litigation unrelated to this
3 class action.
